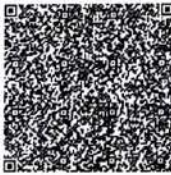
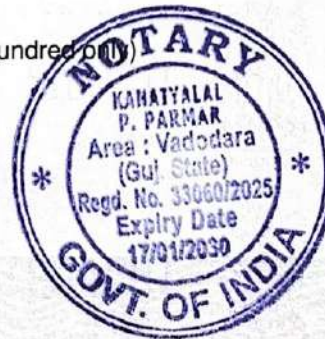

Sumandeep Vidyapeeth Deemed to be University  
At Post Piparia, Taluka Waghodia, District Vadodara, Gujarat state, India.  
(Hereinafter referred to as **DH**)

This MoU is for establishing the collaboration between SHMCH and DH, in the areas of integration of Homoeopathy with Modern Medicine, Capacity building and utilization of advance clinical facilities of Dhiraj Hospital for the benefit of patients and students, development of Homoeopathy science especially in the treatment and rehabilitation of patients suffering from chronic ailments, Health Care Services, Joint Research and Innovation Projects / Studies, Startups, Community / Social Service, Joint Health checkup and Treatment camps, Sharing of Expert knowledge, Training Centre for the students & Interns, Collaborative Conferences / Seminars, Community promotional activities on health, Community based Rehabilitation, Research Publications etc. Dhiraj Hospital will allow and extend all its infrastructural facilities and modern medicine specialist for the purpose of skill development, knowledge resources and teaching – learning, such as Instruments / Equipments, Mobile Van, Ambulance Radiology and Digital Imaging (CT, USG, MRI, X-Ray etc.), Cardiology, Dermatology, Surgery, Obstetrics & Gynaecology, other Departments, books / journals / periodicals, joint community health programs etc.

This collaboration between both the parties herein under is based upon the principles of mutual interest.

#### 1. Preamble

##### About SHMCH:

**Sumandeep Homoeopathic Medical College & Hospital** is a constituent Institute of Sumandeep Vidyapeeth Deemed to be University. The Institute was established in the year 2022 with the approval of National Commission for Homoeopathy and Government of India. The Institute presently has annual intake of 100 seats in undergraduate Bachelor of Homeopathic Medicine and Surgery (BHMS) program.

##### About DH:

**Dhiraj Hospital** is a teaching hospital associated with Smt. B.K. Shah Medical Institute and Research Centre, which is a constituent Institute of Sumandeep Vidyapeeth Deemed to be University. Dhiraj Hospital is a **multi-super-speciality tertiary care 1600 bedded General Hospital** in the Sumandeep campus, which caters to the needs of local population and is the major source of Clinical Research and Academic Research for the Teaching Faculty, Researchers and Students of the

Institution. The hospital is enriched with patients with different types of diseases and anomalies. The hospital is well equipped with state-of-art instruments / equipments, and caters to the needs of patients especially from Madhya Pradesh, Rajasthan and Maharashtra, and Tribal Districts of Gujarat. Dhiraj Hospital also has a state of art Cancer Diagnostic and Treatment facilities. The Molecular Laboratory is NABL accredited and approved by State Government and Indian Council for Medical Research (ICMR) for COVID19 testing facility.

## 2. Scope of the Collaboration:

This MoU is for establishing the collaboration between SHMCH and DH not limited to the following:

1. Integration of Homoeopathy with Modern Medicine
2. Capacity building and utilization of advance clinical facilities of Dhiraj Hospital for the benefit of patients and students
3. Development of Homoeopathy science especially in the treatment and rehabilitation of patients suffering from chronic ailments and in Health Care Services
4. Joint Research and Innovation Projects / Studies, Startups, Community / Social Service, Joint Health checkup and Treatment camps
5. Sharing of Expert knowledge
6. Training Centre for the students & Interns
7. Collaborative Conferences / Seminars, Community promotional activities on health, Community based Rehabilitation, Research Publications etc.
8. Dhiraj Hospital will allow and extend all its infrastructural facilities and modern medicine specialist for the purpose of skill development, knowledge resources and teaching – learning, such as Instruments / Equipments, Mobile Van, Ambulance, Radiology and Digital Imaging (CT, USG, MRI, X-Ray etc.), Cardiology, Dermatology, Surgery, Obstetrics & Gynaecology, other Departments, books / journals / periodicals, joint community health programs etc.

## 3. General Areas of Cooperation:

This MoU will govern the relationship between SHMCH and DH regarding Integration of Homoeopathy with Modern Medicine and utilization of infrastructural facilities. Both SHMCH and DH will encourage constructive interactions among Clinicians, Teaching Faculty members, Auxiliary staff, Students and for Patients, but not limited to the above specified objectives / scope. There will be NO financial obligations to any of the party for undertaking the academic and clinical activity, and No amount will be charged to any of the party towards the expenses incurred during the execution of this MOU.

## 4. Confidential Information:

SHMCH and DH agree for not disclosing any type of confidential material, knowledge, study results or information. The parties may like to share this with one another but may decide not to disclose it to any third party. In the event if it is required to be shared with a third party, except as an when required by law; then mutual consent in writing must be obtained from the other party, prior to disclosure. This Non-Disclosure Agreement (NDA) creates a confidential relationship between the parties to protect any type of confidential and proprietary information or trade secrets.

## 5. Intellectual Property Rights:

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties

agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld.

SHMCH and DH shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

**6. Amendments / Modifications:**

This MoU will be amended / modified / terminated with mutual consent and written agreement, as and when needed.

**7. Legal Effect:**

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

**8. Commencement and Tenure of MOU:**

The present MoU shall become effective from the date of signing. It shall remain in force for the period of **Ten (10) years** i.e. from **07<sup>th</sup> February 2025 till 06<sup>th</sup> February 2035.**

**9. Dispute Resolution:**

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by Vice Chancellor, SVDU.

Sumandeep Homoeopathic Medical College & Hospital and Dhiraj Hospital, welcomes the establishment of this Memorandum for cooperation and jointly agrees to the provisions as set out above.
